

JUDGMENT

This matter came to be heard in a trial on the merits commencing January 17, 2006. After a jury of 12 persons and 2 alternates were chosen, evidence and testimony was presented on behalf of the Plaintiff and Defendant. During the trial, the court made evidentiary rulings and alternatively denied and granted certain motions for directed verdict, all of which are reflected in the trial transcript. Upon conclusion of the trial, the jury alternate was released. After deliberations the jury returned a verdict, attached, on January 26, 2006 in favor of the Plaintiff casting all fault against Defendant River Park Hospital and awarding compensation in the amount of \$7,206,907.80.

It is ORDERED, ADJUDGED and DECREED that there be judgment in favor of Debra Barkes and against River Park Hospital in the amount of SEVEN MILLION TWO HUNDRED SIX THOUSAND NINE HUNDRED SEVEN AND EIGHTY CENTS (\$7,206,907.80), plus interest of 10% to accrue from the date of judgment.


