JURY DEMAND


JUDGMENT

This matter began trial on August 13, 2018. After a jury was impaneled, evidence and testimony was presented after which the jury deliberated.

On August 14, 2018, the jury returned a verdict finding that: Michael Thomson had proven by a preponderance of evidence that Jeffrey Potts committed assault and battery on him that caused harm; that Michael Thomson had proven by a preponderance of evidence that Jeffrey Potts had a specific intent to commit serious personal injury on him on August 14, 2016; that Michael Thomson had proven by clear and convincing evidence that Jeffrey Potts acted intentionally and/or maliciously to commit serious personal injuries on him on August 14, 2016. The jury returned a verdict of compensatory damages in the amount of Eighty-six Million One Hundred Forty-four Thousand Eight Hundred Ten Dollars (\$86,144,810.00) and punitive damages in the amount of Fifteen Million Dollars (\$15,000,000.00). Attached hereto is a copy of the jury verdict form.


It is ORDERED, ADJUDGED and DECREED that there be judgment in favor of Michael Thomson and against Jeffrey Potts in the amount of ONE HUNDRED ONE MILLION ONE HUNDRED FORTY-FOUR THOUSAND EIGHT HUNDRED TEN DOLLARS (\$101,144,810.00), plus interest of 7% to accrue from the date of judgment.

The jury verdict being made the judgment of this Court, JUDGMENT READ,


